She holds a Master of Public Health degree, in the field of Social and Behavioural Change Communication, from the same institution. Teurai also holds a Bachelor of Science degree in Health Education and Health Promotion, from the University of Zimbabwe. She recently qualified for her PhD. Her research entitled "Institutionalization of health promotion in the South African health system", explored health promotion and health systems strengthening in South Africa. The findings from this research has been presented at various local and international conferences. A network of civil society, Teurai is now part of in the country lobbying for an independent South African Health Promotion and Development Foundation among government officials and policy elites is using some evidence from her research to help strengthen the case for a health promotion agenda. She has been invited to be part of a small group to present to the Director-General at the National Department of Health. Teurai was recently offered employment by the SAMRC/Wits Centre for Health Economics and Decision Science (PRICELESS SA) as a Researcher. The work she is involved in includes promoting healthy food environments and policy change, particularly with respect to non-communicable diseases as well as the impact of the COVID-19 pandemic on food security in South Africa. She has also assisted the Wits School of Public Health in collaboration with WHO/TDR, and the University of Ghana's School of Public Health to strengthen capacity in Gender Based Analysis of Vector Borne Diseases and Climate Change through an online short course for the African region.
